This qualification has been **reviewed**. The last date to meet the requirements is 31 December 2018.

### Transition Arrangements

This qualification has been reviewed and replaced by the New Zealand Diploma in Adult and Tertiary Teaching (Level 6) [Ref: 2747].

Those currently enrolled in programmes leading to the expiring qualification may complete or transfer to the new qualification.

The last date for entry for the replaced qualification is 31 December 2017. Providers need to ensure any candidates enrolled in programmes after the listing of the New Zealand qualification will have sufficient time to complete by the last date for assessment.

Existing candidates may either complete programmes leading to the replaced qualification or transfer results to the New Zealand qualification. The last date to meet the requirements of the replaced qualification is 31 December 2018. At that point the qualification will be designated discontinued and from that date no results can be reported against the qualification.

It is anticipated that no existing candidates will be disadvantaged by these transition arrangements. However, anyone who feels that they have been disadvantaged may appeal to NQS at the address below. Appeals will be considered on a case-by-case basis.

### Purpose

The National Diploma in Adult Education and Training (Level 6) is designed for people responsible for management and leadership of adult education and training. People awarded this qualification have demonstrated expertise in the areas of assessment, delivery, design and development, evaluation, Māori education and training, and management of adult education and training.

Holders of this qualification have a substantial depth of knowledge and skills in adult education and training, having met standards selected to suit personal, professional, and employment requirements through the elective sections of the qualification.

This qualification may stand alone or may build on the National Certificate in Adult Education and Training (Level 5) with strands in New Zealand Environment, and International Environment [Ref: 0379].

### Replacement Information

This qualification replaced the National Diploma in Adult Education and Training (Level 5) [Ref: 0380].

### Special Notes

It is recommended that people wishing to undertake this qualification hold credit for standards 4098, and 7091 or 26009.

People may be granted recognition of current competence (RCC) on application to an accredited provider. Candidates for RCC must go through an assessment process carried out by registered assessors in accordance with NZQA guidelines.

### Award of NQF Qualifications

### Transition Arrangements

#### Version 1

This qualification replaced the National Certificate in Adult Education and Training (Level 5) [Ref: 0380] following a planned review of the qualification.

### Summary of differences between qualifications

- qualification was established at Level 6 to provide a clear progression for adult education and training professionals
- the Te Mātauranga Māori me te Whakangungu subfield was included in the requirements of Elective 1
- all domains for the subfields listed in Elective 1 were included.

People currently working towards version 2 of the replaced level 5 qualification may complete that version or transfer their results to the National Diploma (Level 6) [Ref: 1549]. The last date for assessments to take place for the replaced qualification is 31 December 2013. To enable people to complete that qualification:

- an exemption to allow all versions of 7114 to count as level 5 to meet the requirements of the replaced qualification was introduced
- reverse transition to allow candidates to use credit from new Open, Flexible, and Networked Learning domain to count as credit towards expired Open and Distance Learning domain was introduced for the replaced qualification.

It is not intended that any existing candidate be disadvantaged by this review. However, anyone who feels disadvantaged should contact the standard setter at the address below.
